





Immunocytochemistry analysis of JunD in HepG2 cells (green). Samples were incubated in JunD Monoclonal antibody (Product # MA5-45022). The nuclear counter stain is DAPI (blue). Cells were fixed in paraformaldehyde, permeabilized with 0.25% Triton X100/PBS.
