

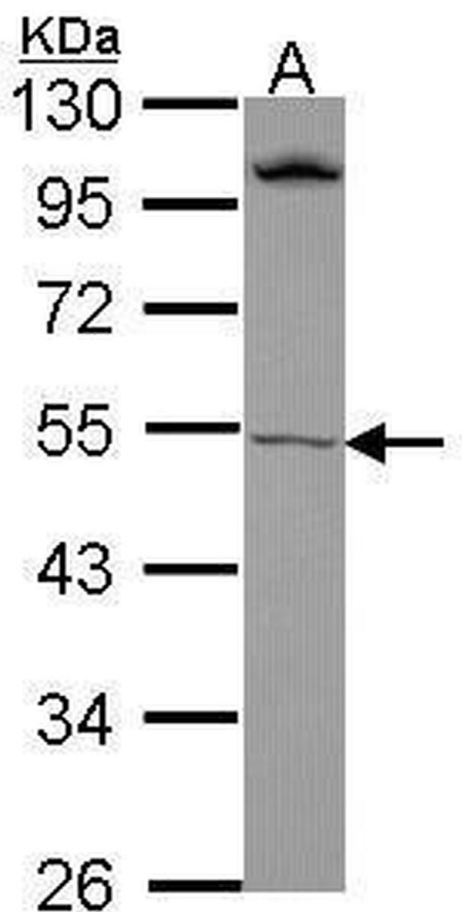


RORB Antibody (PA5-28742) in IHC (F)

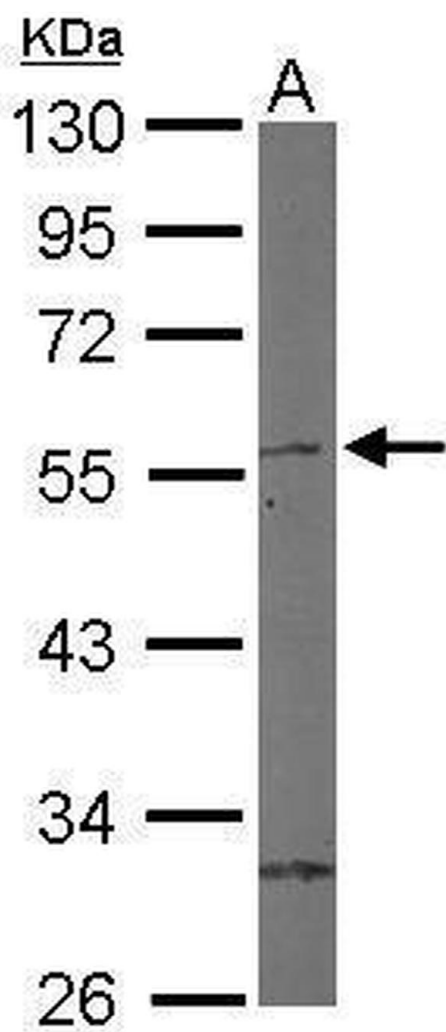
