



Relative expression in different tissues in IHC: Detection of differential expression levels of NUP210L demonstrates antibody specificity. Immunohistochemical analysis of NUP210L using anti-NUP210L Polyclonal Antibody (Product # PA5-64164), shows significant staining of NUP210L in human testis and shows minimal or weak staining in human endometrium tissues.
