


The antibody was affinity-purified from rabbit antiserum by affinity-chromatography using epitope-specific immunogen and the purity is > 95% (by SDS-PAGE).


TSPO Antibody (PA5-75544) in WB

Western blot was performed using TSPO Recombinant Rabbit Monoclonal Antibody (Product # PA5-75544) and a 18 kDa band corresponding to TSPO was observed across cell lines tested and increased upon TPA treatment in THP-1; the expression was low to nil in SK-OV-3, HeLa and Hep G2. Membrane enriched extracts (30 µg lysate) of THP-1 treated with TPA (50 ng/mL for 24 Hours) (Lane 1), THP-1 (Lane 2), Raw 264.7 (Lane 3), SK-O-V3 (Lane 4), HeLa (Lane 5) and HepG2 (Lane 6) were electrophoresed using Novex® NuPAGE® 16 % Tricine gel (Product # EC6695BOX). Resolved proteins were then transferred onto a nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1: 500 dilution) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain), Superclonal™ Recombinant Secondary Antibody, HRP (Product # A27036, 1:4000 dilution) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using Novex® ECL Chemiluminescent Substrate Reagent Kit (Product # WP20005).



TSPO Antibody (PA5-75544)

Antibody specificity was demonstrated by detection of differential basal expression of the target across tissue tested owing to their inherent genetic constitution. Relative expression of TSPO was observed in THP1, Raw 264.7 in comparison to SK-O-V3, HeLa and HepG2 using TSPO Polyclonal Antibody (Product # PA5-75544) in Western Blot. {RE}
