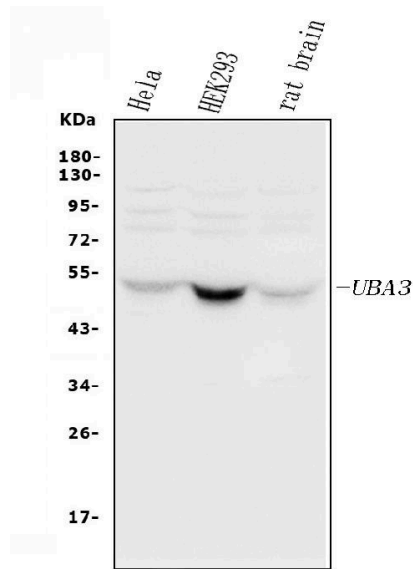

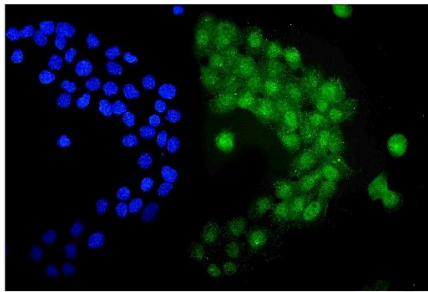
Reconstitute with 0.2 mL of distilled water to yield a concentration of 500 µg/mL.

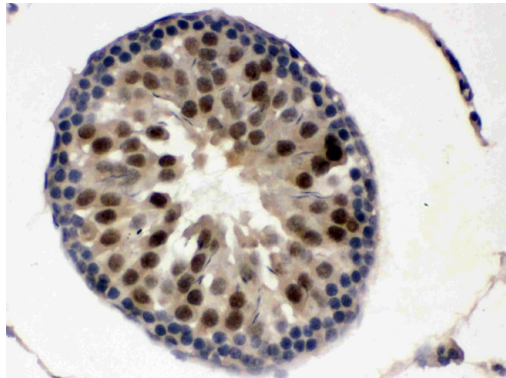
UBA3 Antibody (PA5-80200) in WB

Western blot analysis of UBE1C in, Lane 1: human HeLa whole cell lysate, Lane 2: human HEK293 whole cell lysate, Lane 3: rat brain tissue lysate. Electrophoresis was performed on a 5-20% SDS-PAGE gel at 70V (Stacking gel) / 90V (Resolving gel) for 2-3 hours. The sample well of each lane was loaded with 30 µg of sample under reducing conditions. After Electrophoresis, proteins were transferred to a nitrocellulose membrane at 150 mA for 50-90 minutes. The membrane was blocked with 5% non-fat milk/TBS for 1.5 hour at RT. The membrane was incubated with UBA3 Polyclonal Antibody (Product # PA5-80200) at 0.5 g/mL overnight at 4°C, then washed with TBS-0.1% Tween 3 times with 5 minutes each and probed with a goat anti-rabbit IgG-HRP secondary antibody at a dilution of 1:5,000 for 1.5 hour at RT. The signal is developed using an Enhanced Chemiluminescent detection (ECL) kit. A specific band was detected for UBE1C at approximately 52 kDa. The expected band size for UBE1C is at 52 kDa.



UBA3 Antibody (PA5-80200) in ICC/IF

Immunocytochemistry analysis of UBE1C using anti-UBE1C antibody (Product # PA5-80200). UBE1C was detected in a section of A431 cells. Enzyme antigen retrieval was performed using IHC enzyme antigen retrieval reagent for 15 mins. The cells were blocked with 10% goat serum and then incubated with 2g/mL rabbit anti-UBE1C antibody (Product # PA5-80200) overnight at 4°C. DyLight®488 Conjugated Goat Anti-Rabbit IgG was used as secondary antibody at 1:100 dilution and incubated for 30 minutes at 37°C. The section was counterstained with DAPI. Visualize using a fluorescence microscope and filter sets appropriate for the label used.

Immunohistochemistry analysis of UBA3 on paraffin-embedded mouse testis tissue. Sample was incubated with UBA3 polyclonal antibody (Product# PA5-80200).
