Description: The rat IgG2b kappa monoclonal antibody is useful as an isotype control immunoglobulin.

Applications Reported: This eB149/10H5 antibody has been reported for use in flow cytometric analysis.

Applications Tested: This eB149/10H5 antibody has been tested by flow cytometric analysis of normal human peripheral blood and mouse bone marrow cells. Use at the same concentration as the experimental antibody.

Brilliant Violet[™] 650 (BV650) is a tandem dye that emits at 649 nm and is intended for use on cytometers equipped with a violet (405 nm) laser. Please make sure that your instrument is capable of detecting this fluorochrome.

When using two or more Super Bright, Brilliant Violet™, Brilliant Ultra Violet™, or other polymer dye-conjugated antibodies in a staining panel, it is recommended to use Super Bright Complete Staining Buffer (Product # SB-4401-42) or Brilliant Stain Buffer™ (Product # 00-4409-75) to minimize any non-specific polymer interactions. Please refer to the datasheet for Super Bright Staining Buffer or Brilliant Stain Buffer for more information.

Light sensitivity: This tandem dye is sensitive to photo-induced oxidation. Please protect this vial and stained samples from light.


Fixation: Samples can be stored in IC Fixation Buffer (Product # 00-8222-49) ($100~\mu$ L of cell sample + $100~\mu$ L of IC Fixation Buffer) or 1-step Fix/Lyse Solution (Product # 00-5333-54) for up to 3 days in the dark at 4°C with minimal impact on brightness and FRET efficiency/compensation. Some generalizations regarding fluorophore performance after fixation can be made, but clone-specific performance should be determined empirically.

Our internal testing suggests that Brilliant Violet™ 650 (BV650) is not compatible with methanol-based fixation.
