




FOXC2 Antibody (712371)

Antibody specificity was demonstrated by the detection of differential basal expression of the target across cell models owing to their inherent genetic constitution. Expression of FOXC2 protein was higher in the prostate cancer cell line DU 145 in comparison to LNCaP tested using Anti-FOXC2 Recombinant Rabbit Polyclonal Antibody (Product # 712371) in Western blot. {RE}

Western blot analysis was performed on modified whole cell extracts (1% SDS) (30 µg lysate) of SW480 (Lane 1), Caco-2 (Lane 2) and HT-29 (Lane 3). The blot was probed with Anti-FOXC2 Recombinant Rabbit Polyclonal Antibody (Product #712371, 1:500 dilution) and detected by chemiluminescence using Goat anti-Rabbit IgG (Heavy Chain) Superclonal™ Secondary Antibody, HRP conjugate (Product # A27036, 1:4000 dilution). A ~60 kDa band corresponding to FOXC2 was observed across the cell lines tested.

Western blot analysis was performed on modified whole cell extracts (1% SDS) (30 µg lysate) of DU 145 (Lane 1) and LNCaP (Lane 2). The blot was probed with Anti-FOXC2 Recombinant Rabbit Polyclonal Antibody (Product # 712371, 1:500 dilution) and detected by chemiluminescence using Goat anti-Rabbit IgG (Heavy Chain) Superclonal™ Secondary Antibody, HRP conjugate (Product # A27036, 1: 4000 dilution).
