





IRF4 Antibody (MA1-25525) in WB

Western blot was performed using Anti-IRF4 Monoclonal Antibody (MUM1p) (Product # MA1-25525) and a 51kDa band corresponding to IRF4 was observed in IM9 and not in HEK-293, MCF7 and THP-1 which are reported to be negative. Whole cell extracts (30 µg lysate) of IM9 (Lane 1), HEK-293 (Lane 2), MCF7 (Lane 3) and THP-1 (Lane 4) were electrophoresed using Novex® NuPAGE® 4-12 % Bis-Tris gel (Product # NP0322BOX). Resolved proteins were then transferred onto a nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1:500 dilution) and detected by chemiluminescence with Goat anti-Mouse IgG (H+L), Superclonal[™] Recombinant Secondary Antibody, HRP (Product # A28177, 1:4000 dilution) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using Novex® ECL Chemiluminescent Substrate Reagent Kit (Product # WP20005).

IRF4 Antibody (MA1-25525)

Antibody specificity was demonstrated by detection of differential basal expression of the target across cell lines tested owing to their inherent genetic constitution. Relative expression of IRF4 was observed in IM9 in comparison to HEK-293, MCF7 and THP-1 using Anti-IRF4 Monoclonal antibody (MUM1p) (Product # MA1-25525) in Western Blot. {RE}
