

MA5-12104 targets Cytokeratin 18 in IF, IHC (P), FACS, and WB applications and shows reactivity with Human samples.




Cytokeratin 18 Antibody (MA5-12104) in WB

Western blot analysis was performed on membrane enriched extracts (30 µg lysate) of MCF7 (Lane 1), A549 (Lane 2), A-375 (Lane 3) and A-431 (Lane 4). The blot was probed with anti-Cytokeratin 18 Mouse Monoclonal Antibody (Product # MA5-12104, 2 µg/mL) and detected by chemiluminescence using Goat anti-Mouse IgG (H+L) Superclonal™ Secondary Antibody, HRP conjugate (Product # A28177, 0.25 µg/mL, 1:4000 dilution). A 50 kDa band corresponding to Cytokeratin 18 was observed in MCF7 and A549, and not observed in other cell lines which are documented to be Cytokeratin 18 negative.



Cytokeratin 18 Antibody (MA5-12104)

Antibody specificity was demonstrated by detection of differential basal expression of the target across cell models owing to their inherent genetic constitution. Relative expression of Cytokeratin 18 was observed in MCF7, A549, A-375 and A-431 in Western Blot using Cytokeratin 18 Monoclonal Antibody (Product # MA5-12104). Cytokeratin 18 is reported to be expressed in MCF7 and A549 and not in other cell lines like A-375 and A-431. {RE}



Cytokeratin 18 Antibody (MA5-12104) in WB

Western blot analysis was performed on whole cell and tissue extracts of MCF7 (Lane 1), Mouse prostrate tissue (Lane 2), Hep G2 (Lane 3) and Mouse liver tissue (Lane 4). The blots were probed with Anti-Cytokeratin 18 Mouse Monoclonal Antibody (Product # MA5-12104, 2 µg/mL) and detected by chemiluminescence using Goat anti-Mouse IgG (H+L) Superclonal™ Secondary Antibody, HRP conjugate (Product # A28177, 0.4 µg/mL, 1:2500 dilution). A ~ 50 kDa band corresponding to Cytokeratin 18 was observed across cell line and tissue extracts tested. Known quantity of protein samples were electrophoresed using Novex® NuPAGE® 4-12 % Bis-Tris gel (Product # NP0321BOX), XCell SureLock™ Electrophoresis System (Product # El0002) and Novex® Sharp Pre-Stained Protein Standard (Product # LC5800). Resolved proteins were then transferred onto a nitrocellulose membrane with iBlot® 2 Dry Blotting System (Product # IB21001). The membrane was probed with the relevant primary and secondary Antibody following blocking with 5 % skimmed milk. Chemiluminescent detection was performed using Pierce™ ECL Western Blotting Substrate (Product # 32106).
