
Product Specific Information

The MA5-15886 immunogen is purified recombinant fragment of human MMP9 expressed in E. Coli. .


MA5-15886 detects MMP9 which has a predicted molecular weight of approximately 92kDa.

Antibody specificity was demonstrated by siRNA mediated knockdown of target protein. THP-1 cells were transfected with Matrix metalloproteinase-9 siRNA and decrease in signal intensity was observed in Western Blot application using Anti-MMP9 Monoclonal Antibody (5G3) (Product # MA5-15886). {KD}




MMP9 Antibody (MA5-15886) in ICC/IF

Immunofluorescence analysis of Matrix metalloproteinase-9 was performed using 70% confluent log phase THP-1 cells differentiated to Macrophages using PMA (100nM 48 hours). The cells were fixed with 4% paraformaldehyde for 10 minutes, permeabilized with 0.1% Triton™ X-100 for 15 minutes, and blocked with 2% BSA for 45 minutes at room temperature. The cells were labeled with MMP9 Monoclonal Antibody (5G3) (Product # MA5-15886) at 1:500 dilution in 0.1% BSA, incubated at 4 degree celsius overnight and then labeled with Goat anti-Mouse IgG (H+L) Highly Cross-Adsorbed Secondary Antibody, Alexa Fluor Plus 488 (Product # A32723), (1:2000 dilution), for 45 minutes at room temperature (Panel a: Green). Nuclei (Panel b: Blue) were stained with ProLong™ Diamond Antifade Mountant with DAPI (Product # P36962). F-actin (Panel c: Red) was stained with Rhodamine Phalloidin (Product # R415, 1:300 dilution). Panel d represents the merged image showing cytoplasmic localization. Panel e represents undifferentiated THP-1 cells. Panel f represents control cells with no primary antibody to assess background. The images were captured at 60X magnification.

MMP9 Antibody (MA5-15886) Antibody specificity was demon

Antibody specificity was demonstrated by detection of differential basal expression of the target across cell lines owing to their inherent genetic constitution. Increased expression of both Pro-MMP9 and active MMP9 was observed in THP-1 cells differentiated to Macrophages by PMA (100nM, 48 hours) treatment and THP-1 differentiated to Macrophages using PMA and treated with Protein Transport Inhibitor (PTI); against THP-1 cells and THP-1 treated with PTI, using Anti-MMP9 Monoclonal Antibody (5G3) (Product # MA5-15886) in Western Blot. {RE}
