



BRCA2 Antibody (MA5-23942) in WB

Western blot analysis from lysates of Capan-1 human pancreatic adenocarcinoma cell line, HeLa human cervical epithelial carcinoma cell line, and U2OS human osteosarcoma cell line. PVDF membrane was probed with 0.2 µg /mL of human BRCA2 Monoclonal Antibody (Product # MA5-23942) followed by HRP-conjugated Anti-mouse IgG Secondary Antibody. A specific band was detected for BRCA2 at approximately 380 kDa (as indicated). This experiment was conducted under reducing conditions.

BRCA2 in Human Breast Cancer Tissue. BRCA2 was detected in immersion fixed paraffin-embedded sections of human breast cancer tissue using BRCA2 Monoclonal Antibody (Product # MA5-23942) at 5 µg/mL for 1 hour at room temperature followed by incubation with the Anti-Mouse IgG HRP Antibody. Before incubation with the primary antibody, tissue was subjected to heat-induced epitope retrieval. Tissue was stained using DAB (brown) and counterstained with hematoxylin (blue). Specific staining was localized to cytoplasm and nuclei in epithelial cells.
