






VSIG2 Antibody (MA5-25340) in WB

Western blot analysis of VSIG2 in HepG2, HeLa, HT29, A549, COS7, Jurkat, MDCK, PC12, MCF7 cells using 35 μ g per lane. Samples were probed with VSIG2 (Product # MA5-25340) monoclonal antibody.

Immunofluorescent analysis of VSIG2 in COS7 cells. Cells were transfected with a plasmid overexpressing VSIG2 and probed with a VSIG2 monoclonal antibody (Product # MA5-25340).

Western blot analysis of VSIG2 in HEK293T cells in untransfected (Left lane) and transfected (Right lane) samples using 5 μ g per lane. The samples were separated by SDS-PAGE and probed with VSIG2 (Product # MA5-25340) monoclonal antibody.
