






Kallikrein 8 Antibody (MA5-26252) in WB

Western blot analysis of KLK8 in HepG2, HeLa, SVT2, A549, COS7, Jurkat, MDCK, PC12 and MCF7 cells using 35 µg per lane. Samples were separated by SDS-PAGE and probed with KLK8 (Product # MA5-26252) monoclonal antibody.

Immunofluorescent analysis of KLK8 in COS7 cells. Cells were transfected with a plasmid overexpressing KLK8 and probed with a KLK8 monoclonal antibody (Product # MA5-26252).



Kallikrein 8 Antibody (MA5-26252) in IHC (P)

Immunohistochemistry was performed on paraffin-embedded carcinoma of human thyroid tissue. To expose target proteins, 10mM citric buffer, pH6.0, 120° C for 3min was used. Following antigen retrieval, tissues were probed with a KLK8 monoclonal antibody (Product # MA5-26252).
