


UBE2D2 Antibody (MA5-26804) in IHC (P)

Immunohistochemistry was performed on paraffin-embedded human lymphoma tissue. To expose target proteins, 1 mM EDTA in 10mM Tris, pH8.5, 120°C for 3min was used. Following antigen retrieval, tissues were probed with a UBE2D2 monoclonal antibody (Product # MA5-26804).
