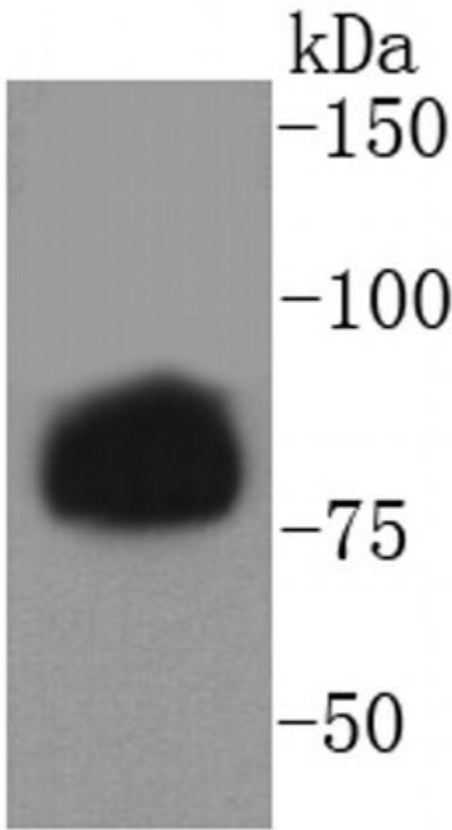
## Product Specific Information
