
Product Specific Information

PA1-773 detects recombinant rat and mouse rab 3D. This antibody does not detect rab 3A, 3B, or 3C.

PA1-773 has been successfully used in Western blot procedures. By Western blot, this antibody detects an ~29 kDa protein representing recombinant mouse rab 3D.

PA1-773 immunogen is a synthetic peptide corresponding to residues M(1) A S A S E P P A S P R D A A D Q N(18) of rat RAB3D. This sequence is completely conserved in mouse. This immunizing peptide (Cat. # PEP-144) is available for use in neutralization and control experiments.

RAB3d Antibody (PA1-773) in ICC/IF

Immunofluorescence analysis of RAB3D was performed using 70% confluent log phase 3T3-L1 cells. The cells were fixed with 4% paraformaldehyde for 10 minutes, permeabilized with 0.1% Triton™ X-100 for 10 minutes, and blocked with 1% BSA for 1 hour at room temperature. The cells were labeled with RAB3D Rabbit Polyclonal Antibody (Product # PA1-773) at 2µg/mL in 0.1% BSA and incubated for 3 hours at room temperature and then labeled with Goat anti-Rabbit IgG (Heavy Chain) Superclonal™ Secondary Antibody, Alexa Fluor® 488 conjugate (Product # A27034) at a dilution of 1:2000 for 45 minutes at room temperature (Panel a: green). Nuclei (Panel b: blue) were stained with SlowFade® Gold Antifade Mountant with DAPI (Product # S36938). F-actin (Panel c: red) was stained with Alexa Fluor® 555 Rhodamine Phalloidin (Product # R415, 1:300). Panel d represents the merged image showing membranous localization. Panel e shows the no primary antibody control. The images were captured at 60X magnification.
