

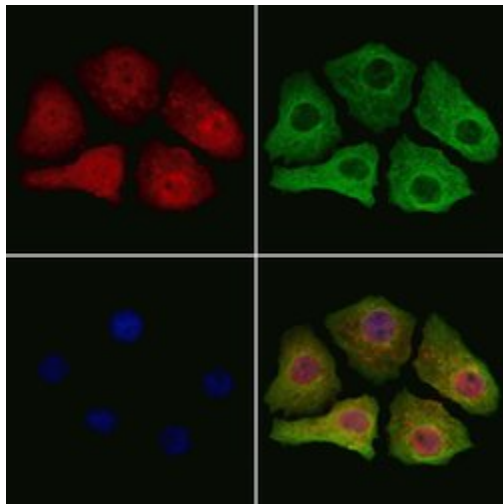

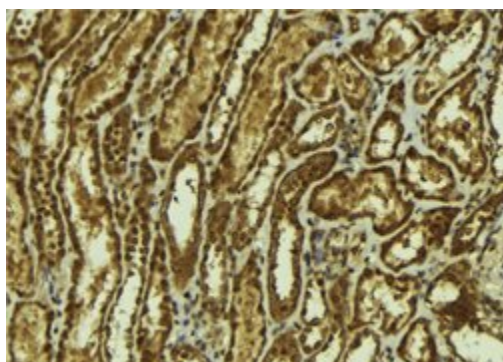

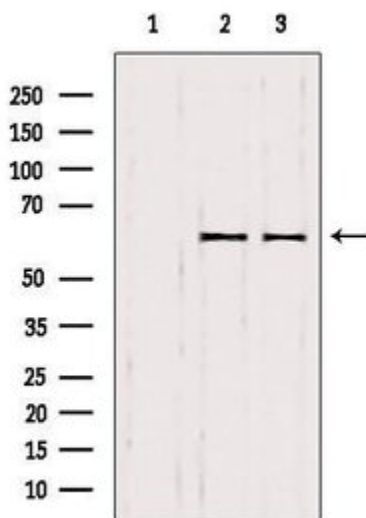
SMOX Antibody (PA5-100112) in IF

Immunofluorescent analysis of SMOX in HeLa cells. Samples were fixed with paraformaldehyde, permeabilized with 0.1% Triton X-100, blocked with 10% serum (45 min at 25°C), incubated with mouse anti-beta tubulin and SMOX polyclonal antibody (Product # PA5-100112) using a dilution of 1:200 (1 hr, 37°C), and followed by goat anti-rabbit IgG Alexa Fluor 594 (red) and goat anti-mouse IgG Alexa Fluor 488 (green).



SMOX Antibody (PA5-100112) in IHC (P)

Immunohistochemistry analysis of paraffin-embedded SMOX in mouse kidney tissue. Antigen retrieval was performed using citrate buffer. Samples were blocked with blocking buffer (1.5 hr, 22°C), incubated with SMOX polyclonal antibody (Product # PA5-100112) using a dilution of 1:100 (1.5 hr, 22°C), followed by HRP conjugated goat anti-rabbit.

Western blot analysis of SMOX in various samples (Lane 1: rat brain treated with blocking peptide, Lane 2: rat brain, Lane 3: 293). Samples were incubated with SMOX polyclonal antibody (Product # PA5-100112).
