




hnRNP R Antibody (PA5-100559) in ICC/IF

Immunocytochemistry analysis of hnRNP R in HepG2 cells. The samples were fixed with PFA and permeabilized in 0.1% Triton X-100, then blocked in 10% serum for 45 minutes at 25°C. Samples were incubated with hnRNP R polyclonal antibody (Product # PA5-100559) and mouse anti-beta tubulin antibody for 1 hour at 37°C. An AlexaFluor594 conjugated goat anti-rabbit IgG(H+L) (Red) and an AlexaFluor488 conjugated goat anti-mouse IgG(H+L) (Green) were used as the secondary antibodies. The nuclear counter stain is DAPI (blue).

Immunohistochemistry analysis of hnRNP R in human normal tissues adjacent to esophageal cancer. The sample was formaldehyde fixed and a heat mediated antigen retrieval step in citrate buffer was performed. Samples were incubated with hnRNP R polyclonal antibody (Product # PA5-100559) using a dilution of 1: 100 (4°C overnight) followed by HRP conjugated anti-Rabbit secondary antibody.

Immunohistochemistry analysis of hnRNP R in mouse testis tissue. The sample was formaldehyde fixed and a heat mediated antigen retrieval step in citrate buffer was performed. Samples were incubated with hnRNP R polyclonal antibody (Product # PA5-100559) using a dilution of 1:100 (4°C overnight) followed by HRP conjugated anti-Rabbit secondary antibody.
