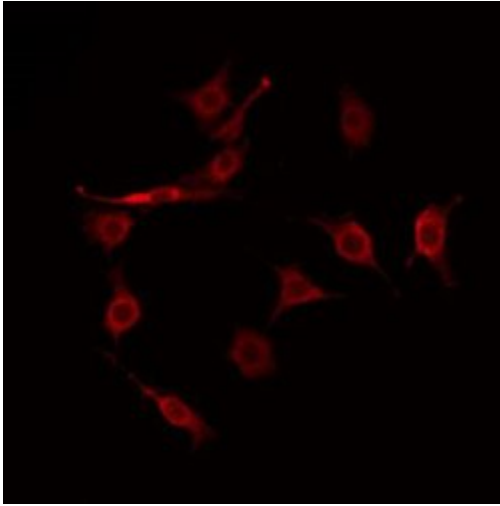

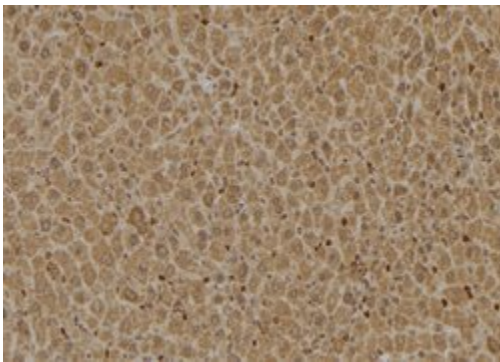

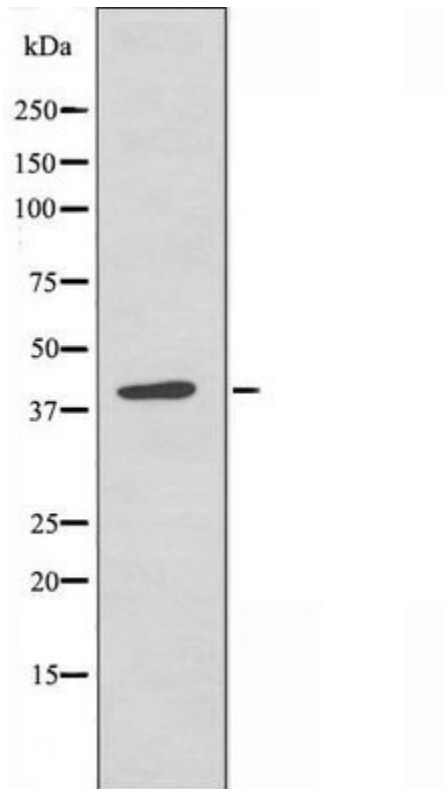
HGH1 Antibody (PA5-101467) in ICC/IF

Immunofluorescent analysis of HGH1 in COLO205 cells. Samples were fixed with paraformaldehyde, permeabilized with 0.1% Triton X-100, blocked with 10% serum (45 min at 25°C) incubated with HGH1 polyclonal antibody (Product # PA5-101467) using a dilution of 1:200 (1 hr, 37°C), and followed by goat anti-rabbit IgG Alexa Fluor 594 at a dilution of 1:600.



HGH1 Antibody (PA5-101467) in IHC (P)

Immunohistochemistry analysis of paraffin-embedded HGH1 in mouse liver tissue. Antigen retrieval was performed using citrate buffer. Samples were blocked with blocking buffer (1.5 hr, 22°C), incubated with HGH1 polyclonal antibody (Product # PA5-101467) using a dilution of 1:100 (1.5 hr, 22°C), followed by HRP conjugated goat anti-rabbit.

Western blot analysis of HGH1 in COLO cells. Samples were incubated with HGH1 polyclonal antibody (Product # PA5-101467).
