



#### p23 Antibody (PA5-102730) in IHC (P)

Immunohistochemistry analysis of paraffin-embedded p23 in human kidney tissue. Antigen retrieval was performed using citrate buffer. Samples were blocked with blocking buffer (1.5 hr, 22°C), incubated with p23 polyclonal antibody (Product # PA5-102730) using a dilution of 1:100 (1.5 hr, 22°C), followed by HRP conjugated goat anti-rabbit.
