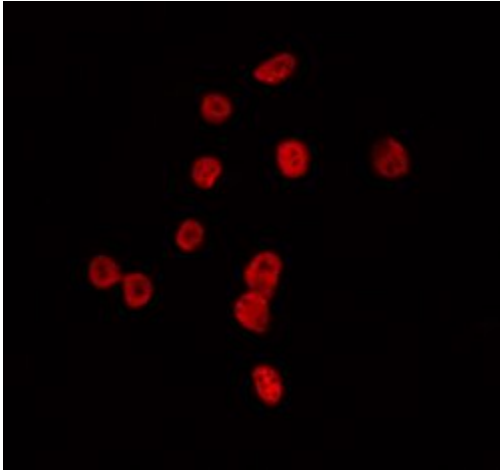

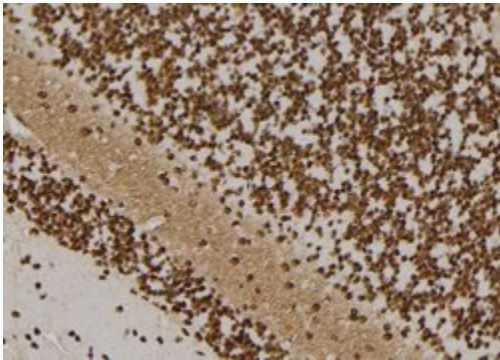

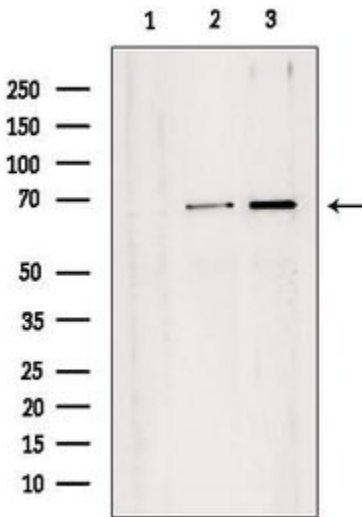
### TAF1B Antibody (PA5-104353) in ICC/IF

Immunofluorescent analysis of TAF1B in HepG2. Samples were fixed with paraformaldehyde, permeabilized with 0.1% Triton X-100, blocked with 10% serum (45 min at 25°C) incubated with TAF1B polyclonal antibody (Product # PA5-104353) using a dilution of 1:200 (1 hr, 37°C), and followed by goat anti-rabbit IgG Alexa Fluor 594 at a dilution of 1:600.



### TAF1B Antibody (PA5-104353) in IHC (P)

Immunohistochemistry analysis of paraffin-embedded TAF1B in rat brain tissue. Antigen retrieval was performed using citrate buffer. Samples were blocked with blocking buffer (1.5 hr, 22°C), incubated with TAF1B polyclonal antibody (Product # PA5-104353) using a dilution of 1:100 (1.5 hr, 22°C), followed by HRP conjugated goat anti-rabbit.



### TAF1B Antibody (PA5-104353) in WB

Western blot analysis of TAF1B in various samples (Lane 1: mouse brain treated with blocking peptide, Lane 2: mouse brain, Lane 3: rat brain). Samples were incubated with TAF1B polyclonal antibody (Product # PA5-104353).
