

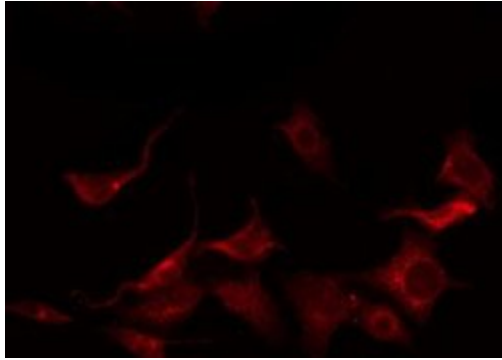

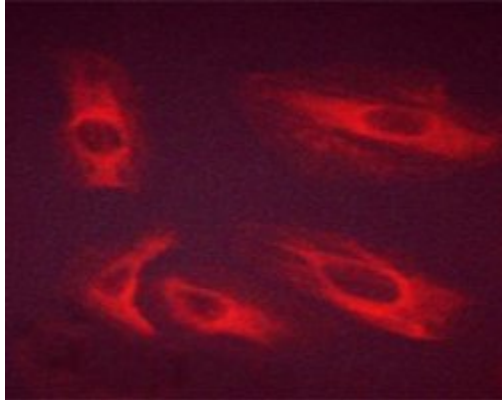

### Phospho-FGFR1 (Tyr654) Antibody (PA5-104789) in IF

Immunofluorescent analysis of Phospho-FGFR1 (Tyr654) in HepG2. Samples were fixed with paraformaldehyde, permeabilized with 0.1% Triton X-100, blocked with 10% serum (45 min at 25°C) incubated with Phospho-FGFR1 (Tyr654) polyclonal antibody (Product # PA5-104789) using a dilution of 1:200 (1 hr, 37°C), and followed by goat anti-rabbit IgG Alexa Fluor 594 at a dilution of 1:600.

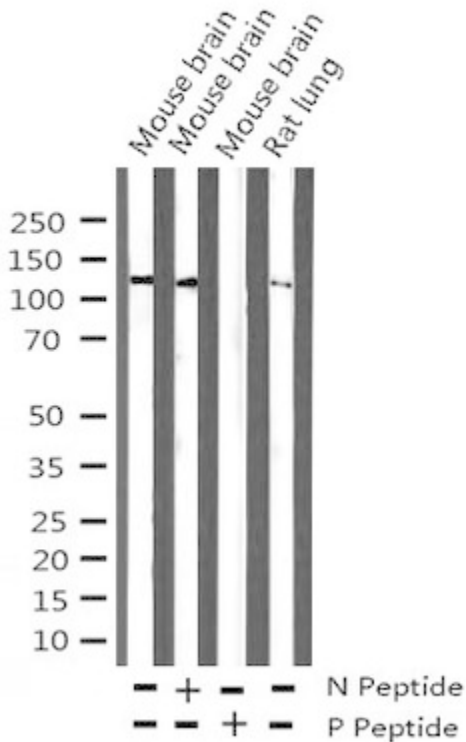


### Phospho-FGFR1 (Tyr654) Antibody (PA5-104789) in IF

Immunofluorescent analysis of Phospho-FGFR1 (Tyr654) in COS7 cells. Samples were fixed with paraformaldehyde, permeabilized with 0.1% saponin, blocked with 10% serum (45 min, 37°C) incubated with Phospho-FGFR1 (Tyr654) polyclonal antibody (Product # PA5-104789) using a dilution of 1:400 (1 hr, 37°C), and followed by goat anti-rabbit IgG Alexa Fluor 594 at a dilution of 1:600.

### Phospho-FGFR1 (Tyr654) Antibody (PA5-104789) in WB

Western blot analysis of Phospho-FGFR1 (Tyr654) in mouse brain/rat lung (absence (-) or presence (+) of non-phospho and phospho peptide). Samples were incubated with Phospho-FGFR1 (Tyr654) polyclonal antibody (Product # PA5-104789).
