


Antibody detects endogenous levels of MUNC-18a only when phosphorylated at Ser313.

Phospho-STXBP1 (Ser313) Antibody (PA5-105191) in ICC/IF

Immunocytochemistry analysis of Phospho-STXBP1 (Ser313) in A549 cells (H2O2 treatment). The samples were fixed with PFA and permeabilized in 0.1% Triton X-100, then blocked in 10% serum for 45 minutes at 25°C. Samples were incubated with Phospho-STXBP1 (Ser313) polyclonal antibody (Product # PA5-105191) and mouse anti-beta tubulin antibody for 1 hour at 37°C. An AlexaFluor594 conjugated goat anti-rabbit IgG (Red) and an AlexaFluor488 conjugated goat anti-mouse IgG (Green) were used as the secondary antibodies. The nuclear counter stain is DAPI (blue).
