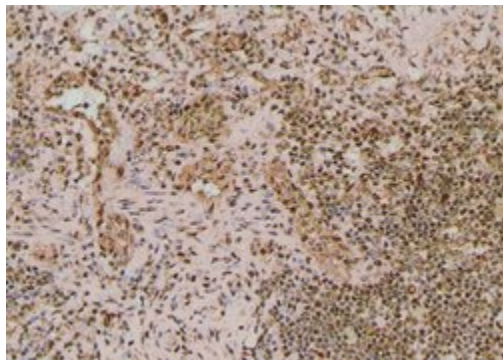

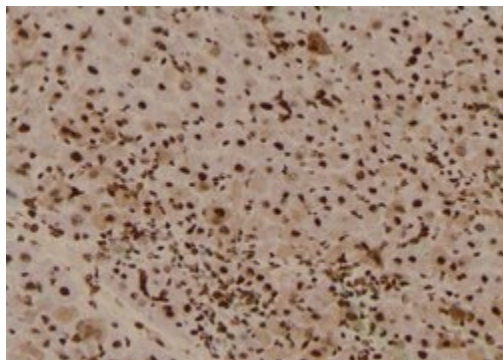

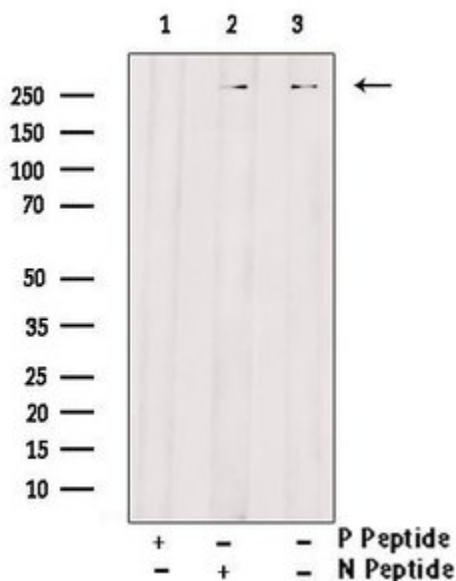
Phospho-BRCA2 (Ser2095) Antibody (PA5-105585) in IHC (P)

Immunohistochemistry analysis of paraffin-embedded Phospho-BRCA2 (Ser2095) in human spleen tissue sections. Antigen retrieval was performed using citrate buffer. Samples were blocked with blocking buffer (1.5 hr, 22°C), incubated with Phospho-BRCA2 (Ser2095) polyclonal antibody (Product # PA5-105585) using a dilution of 1:100 (1.5 hr, 22°C), followed by HRP conjugated goat anti-rabbit.
