





"PA5-105763 was used in Immunohistochemistry to show that Nogo-B enhances the migration and invasion potency of NPC cells via EMT by binding to its receptor NgR3 to regulate the RhoA-SRF-MRTFA pathway, which could provide a novel insight into understanding the metastasis mechanism and targeted therapy of advanced NPC."
