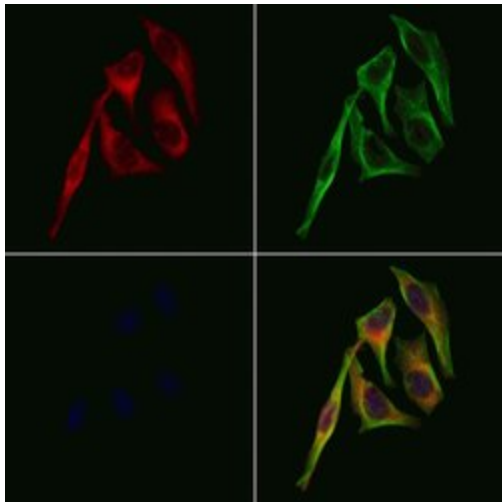

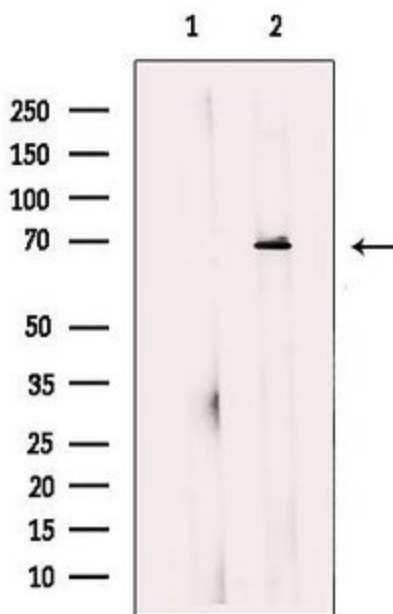


Dopamine Transporter Antibody (PA5-106751) in IF

Immunofluorescent analysis of Dopamine Transporter in 3T3 cells. Samples were fixed with paraformaldehyde, permeabilized with 0.1% Triton X-100, blocked with 10% serum (45 min at 25°C), incubated with mouse anti-beta tubulin and Dopamine Transporter polyclonal antibody (Product # PA5-106751) using a dilution of 1:200 (1 hr, 37°C), and followed by goat anti-rabbit IgG Alexa Fluor 594 (red) and goat anti-mouse IgG Alexa Fluor 488 (green).

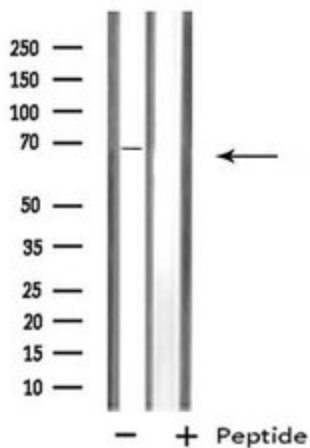
