



## CRX Antibody (PA5-109592) in ICC/IF

Immunofluorescence analysis of CRX in mouse retina cells. Samples were incubated with CRX Polyclonal antibody (Product # PA5-109592) using a dilution of 1:200 (40x lens). Blue: DAPI for nuclear staining.



#### CRX Antibody (PA5-109592) in WB

Western blot analysis of CRX in extracts of mouse eye. Samples were incubated with CRX Polyclonal antibody (Product # PA5-109592) using a dilution of 1: 1,000, followed by HRP Goat Anti-Rabbit IgG (H+L) at a dilution of 1:10,000. Lysates/proteins: 25 µg per lane. Blocking buffer: 3% nonfat dry milk in TBST. Detection: ECL Basic Kit. Exposure time: 180s.
