



Western Blot analysis of ALOX15B in multiple sample types using a ALOX15B polyclonal antibody (Product # PA5-112355) at a concentration of 11 μ g/ml. A goat anti rabbit polyclonal secondary antibody was used at a dilution of 1:10,000. Sample types that were tested include: Lane 1: MCF-7 whole cell lysate, Lane 2: 293T whole cell lysate.
