






C1 inhibitor Antibody (PA5-13627) in ICC/IF

Immunofluorescent analysis of NCI-H292 cells using a SERPING1 polyclonal antibody (Product # PA5-13627) at a dilution of 1:10-50, followed by a fluor-conjugated goat anti-rabbit secondary antibody (green). Nuclei were stained with DAPI (blue).
