




FAK Antibody (PA5-17591)

Antibody specificity was demonstrated by siRNA mediated knockdown of the target protein. A549 cells were transfected with FAK/PTK2 siRNA and decrease in signal intensity was observed in western blot application using FAK Antibody (Product # PA5-17591). {KD}



FAK Antibody (PA5-17591) in ICC/IF

Immunofluorescence analysis of FAK was performed using 70% confluent log phase A549 cells. The cells were fixed with 4% paraformaldehyde for 10 minutes, permeabilized with 0.1% Triton™ X-100 for 10 minutes, and blocked with 2% BSA for 1 hour at room temperature. The cells were labeled with FAK Polyclonal Antibody (Product # PA5-17591) at 1:100 dilution in 0.1% BSA and incubated overnight at 4 degree and then labeled with Goat anti-Rabbit lgG (Heavy Chain) Superclonal™ Secondary Antibody, Alexa Fluor® 488 conjugate (Product # A27034) at a dilution of 1:2000 for 45 minutes at room temperature (Panel a: green). Nuclei (Panel b: blue) were stained with SlowFade® Gold Antifade Mountant with DAPI (Product # S36938). F-actin (Panel c: red) was stained with Rhodamine Phalloidin (Product # R415, 1:300). Panel d represents the merged image showing localization at focal adhesions. Panel e represents control cells with no primary antibody to assess background. The images were captured at 60X magnification.

Antibody specificity was demonstrated by siRNA mediated knockdown of target protein. HeLa cells were transfected with FAK siRNA and loss of signal was observed in immunofluorescence analysis using FAK Polyclonal antibody (Product # PA5-17591). {KD}
