PA5-21998 targets AMPK gamma-2 in ICC, IF, and WB applications and shows reactivity with Human and mouse samples.

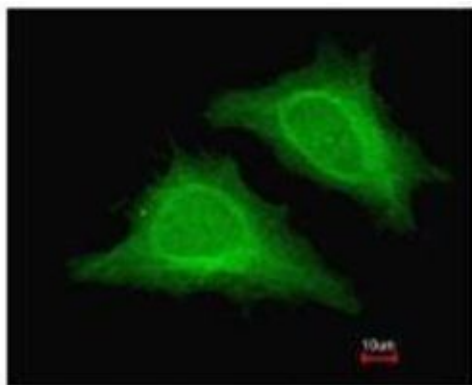
The PA5-21998 immunogen is a recombinant fragment corresponding to a region within amino acids 192 and 569 of AMPK gamma 2 (Uniprot ID#Q9UGJ0).

Store product as a concentrated solution. Centrifuge briefly prior to opening the vial. For short-term storage (1-2 weeks), product can be stored at 4°C. For long-term storage, aliquot and store product at -20° C or below, avoiding multiple freeze-thaw cycles.

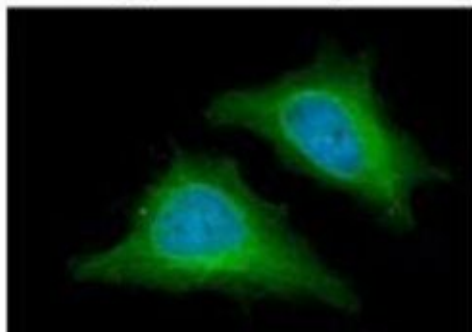

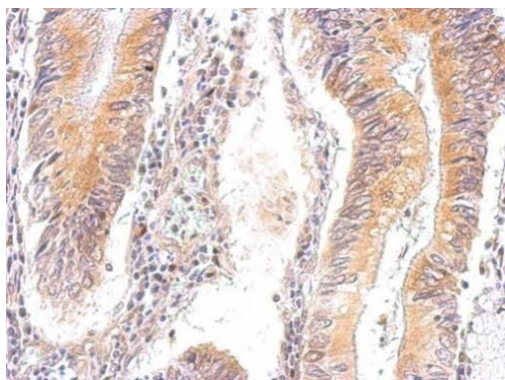


Merged with DNA probe



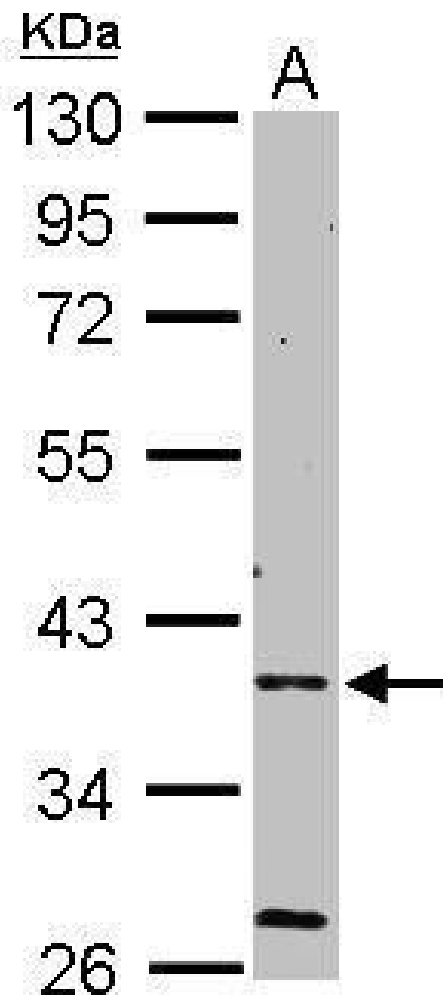
AMPK gamma-2 Antibody (PA5-21998) in IHC (P)
