


Store product as a concentrated solution. Centrifuge briefly prior to opening the vial.


RAB6A Antibody (PA5-22127) in WB

Western Blot analysis of RAB6A was performed by separating 30 μ g of various whole cell lysates by 12 % SDS-PAGE. Proteins were transferred to a membrane and probed with a RAB6A Polyclonal Antibody (Product # PA5-22127) at a dilution of 1:1000. A. A549, B. H1299 , C. HCT116.

Immunocytochemistry-Immunofluorescence analysis of RAB6A was performed in A549 cells fixed in 4% paraformaldehyde at RT for 15 min. Green: RAB6A Polyclonal Antibody (Product # PA5-22127) diluted at 1:500. Blue: Hoechst 33342 staining. Scale bar = $10 \mu m$.
