

Predicted reactivity: Mouse (91%), Rat (93%), Bovine (95%).


Store product as a concentrated solution. Centrifuge briefly prior to opening the vial.


PEX19 Antibody (PA5-22129) in WB

Western blot analysis was performed on membrane enriched extracts (30 µg lysate) of HeLa (Lane 1), PC-12 (Lane 2), Raji (Lane 3), K-562 (Lane 4), Jurkat (Lane 5), THP-1 (Lane 6), NTERA-2 (Lane 7) and LNCap (Lane 8). The blot was probed with Anti- PEX19 Polyclonal Antibody (Product # PA5-22129, 1 µg/mL) and detected by chemiluminescence using Goat anti Rabbit IgG (Heavy Chain) Superclonal™ Secondary Antibody, HRP conjugate (Product # A27036, 0.25 µg/mL, 1:4,000 dilution). A 37 kDa band corresponding to PEX19 was detected across the cell lines tested.



PEX19 Antibody (PA5-22129)

Antibody specificity was demonstrated by siRNA mediated knockdown of target protein. HeLa cells were transfected with PEX19 siRNA and reduction of signal was observed in Western Blot using PEX19 Polyclonal Antibody (Product # PA5-22129). {KD}

PEX19 Polyclonal Antibody detects PEX19 protein by western blot analysis. A. 30 μg PC-12 whole cell lysate/extract. B. 30 μg Rat-2 whole cell lysate/extract. 10% SDS-PAGE. PEX19 Polyclonal Antibody (Product # PA5-22129) dilution: 1: 1,000. The HRP-conjugated anti-rabbit IgG antibody was used to detect the primary antibody.
