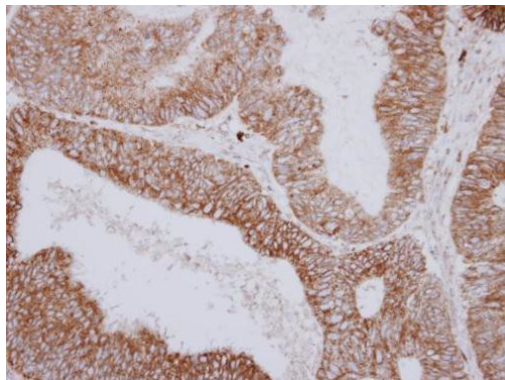

Predicted reactivity: Human (99%), Mouse (93%), Rat (95%), Pig (94%), Bovine (93%).

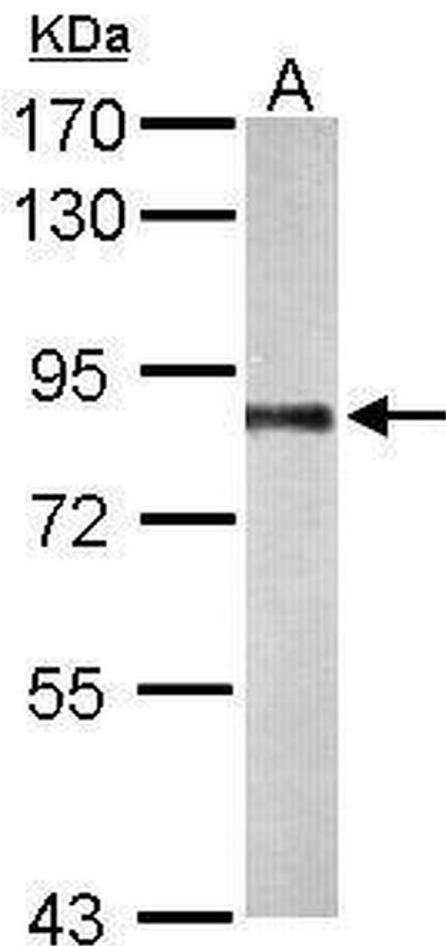
Store product as a concentrated solution. Centrifuge briefly prior to opening the vial.

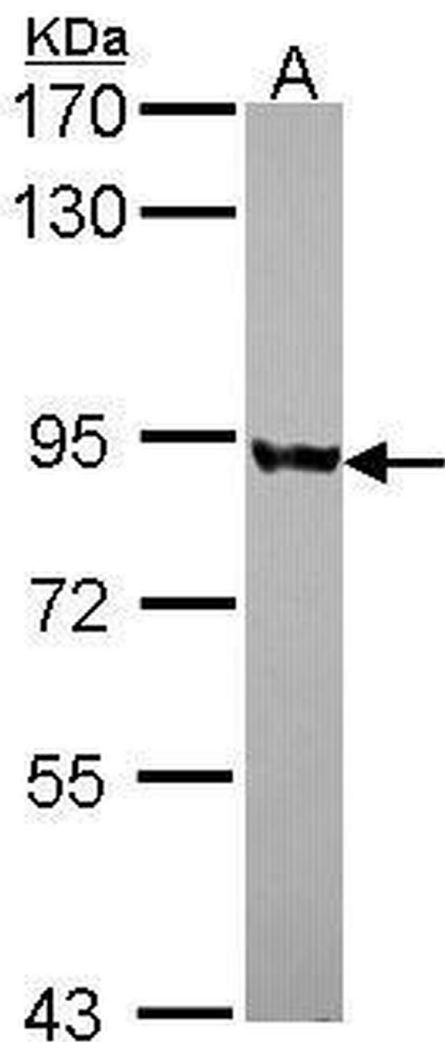
#### PNPase Antibody (PA5-22396) in IHC (P)
