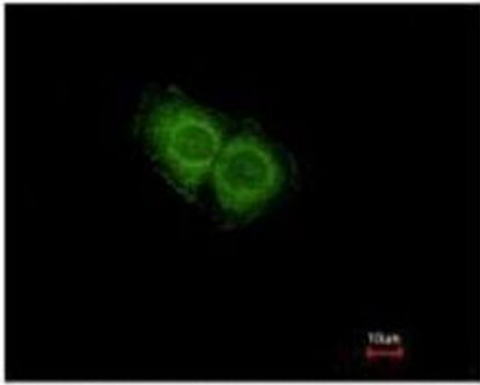

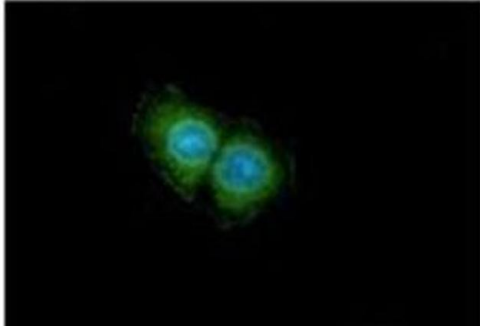
Predicted reactivity: Chimpanzee (100%).

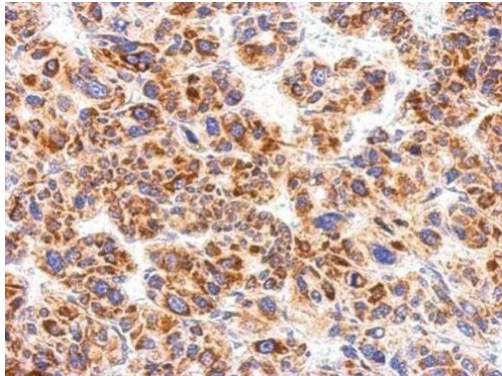

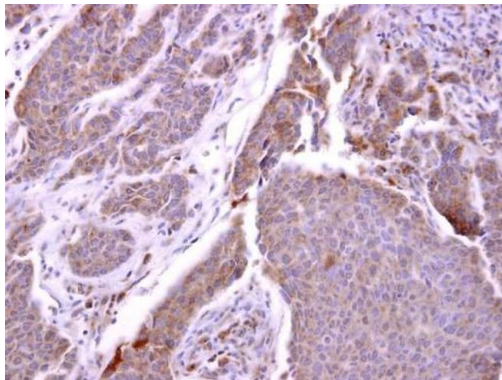
CXCR1 Antibody (PA5-27184) in ICC/IF
