




PYCARD Antibody (PA5-27715) in WB

Western blot was performed using Anti-PYCARD Polyclonal Antibody (Product # PA5-27715) and a 21kDa band corresponding to Apoptosis-associated specklike protein containing a CARD was observed across the cell lines tested. Whole cell extracts (30 µg lysate) of MCF7 (Lane 1), THP-1 (Lane 2), HL-60 (Lane 3), K-562 (Lane 4), HeLa (Lane 5), Jurkat (Lane 6) were electrophoresed using NuPAGETM 4-12% Bis-Tris Protein Gel (Product # NP0322BOX). Resolved proteins were then transferred onto a Nitrocellulose membrane (Product # IB23002) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1:1000) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain) SuperclonalTM Recombinant Secondary Antibody, HRP (Product # A27036, 1:4000) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using Novex® ECL Chemiluminescent Substrate Reagent Kit (Product # WP20005).

Antibody specificity was demonstrated by detection of differential basal expression of the target across MCF-7, THP-1, HL-60, K-562, HeLa, Jurkat owing to their inherent genetic constitution. Relative expression of Apoptosis-associated speck-like protein containing a CARD was observed to be high in MCF-7, THP-1, HL-60, K-562 when compared to HeLa and Jurkat using Anti-PYCARD Polyclonal Antibody (Product # PA5-27715) in Western Blot. {RE}
