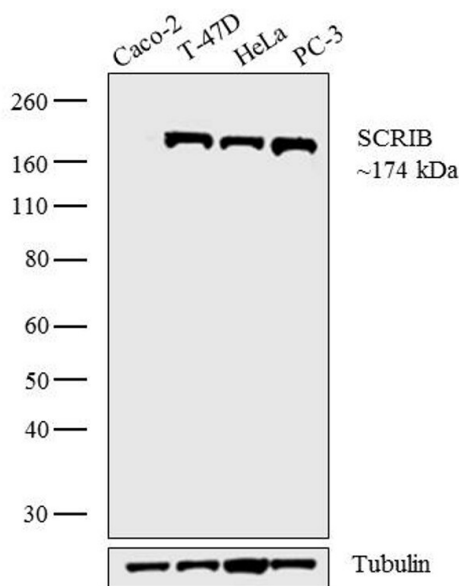
PA5-28628 targets SCRIB in WB and IHC (P) applications and shows reactivity with Human and mouse samples.

Store product as a concentrated solution. Centrifuge briefly prior to opening the vial. For short-term storage (1-2 weeks), product can be stored at 4°C. For long-term storage, aliquot and store product at -20° C or below, avoiding multiple freeze-thaw cycles.

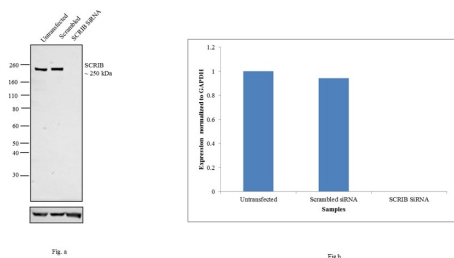
SCRIB Antibody (PA5-28628)

Antibody specificity was demonstrated by detection of differential basal expression of the target across cell models owing to their inherent genetic constitution. Western blot analysis using SCRIB Polyclonal antibody (Product # PA5-28628) showed lower expression of SCRIB in Caco-2 cell line when compared to other cell lines. 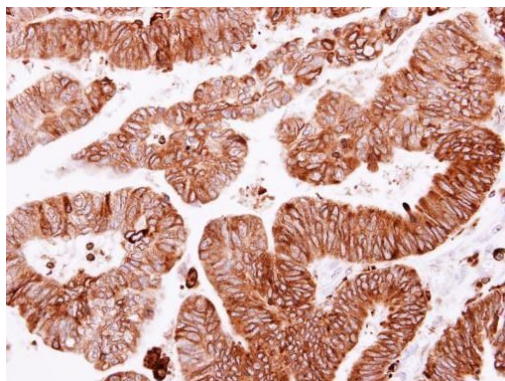


SCRIB Antibody (PA5-28628)

Antibody specificity was demonstrated by siRNA mediated knockdown of target protein. HeLa cells were transfected with SCRIB siRNA and reduction of signal was observed in Western Blot using SCRIB Polyclonal Antibody (Product # PA5-28628). KnockDown validation info.
