PA5-29287 targets c-Abl in IF, IHC (P), and WB applications and shows reactivity with Human samples.

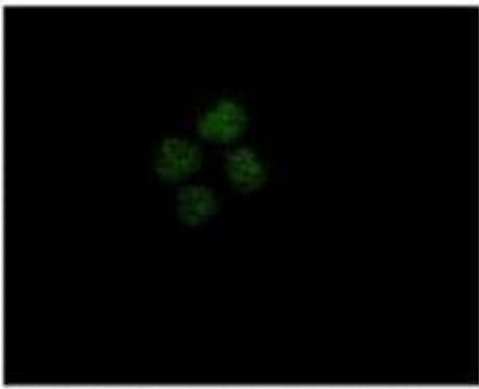
The PA5-29287 immunogen is recombinant protein fragment corresponding to a region within amino acids 905 and 1089 of Human c-Abl.

Store product as a concentrated solution. Centrifuge briefly prior to opening the vial. For short-term storage (1-2 weeks), product can be stored at 4°C. For long-term storage, aliquot and store product at -20° C or below, avoiding multiple freeze-thaw cycles.

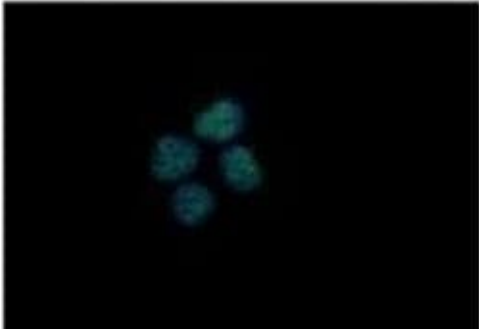

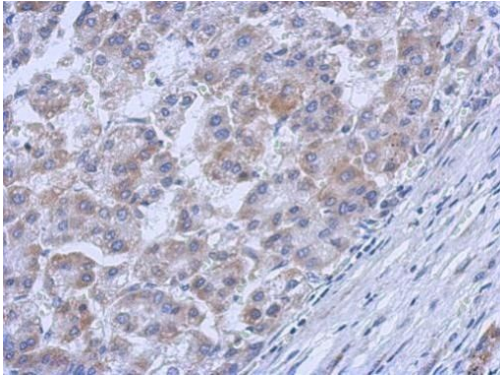


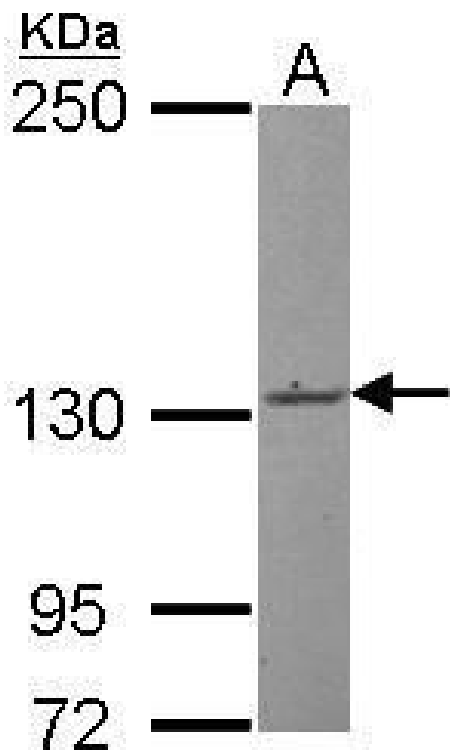

Western blot analysis of c-Abl using 30  $\mu$ g of Jurkat lysate. Samples were loaded onto a 5% SDS-PAGE gel and probed with a c-Abl polyclonal antibody (Product # PA5-29287) at a dilution of 1:500.
