

Store product as a concentrated solution. Centrifuge briefly prior to opening the vial.




HSD17B3 Antibody (PA5-30063) in ICC/IF

Various whole cell extracts (30 μ g) were separated by 12% SDS-PAGE, and the membrane was blotted with HSD17B3 Polyclonal Antibody (Product # PA5-30063) diluted at 1:1,000. The HRP-conjugated anti-rabbit IgG antibody was used to detect the primary antibody.
