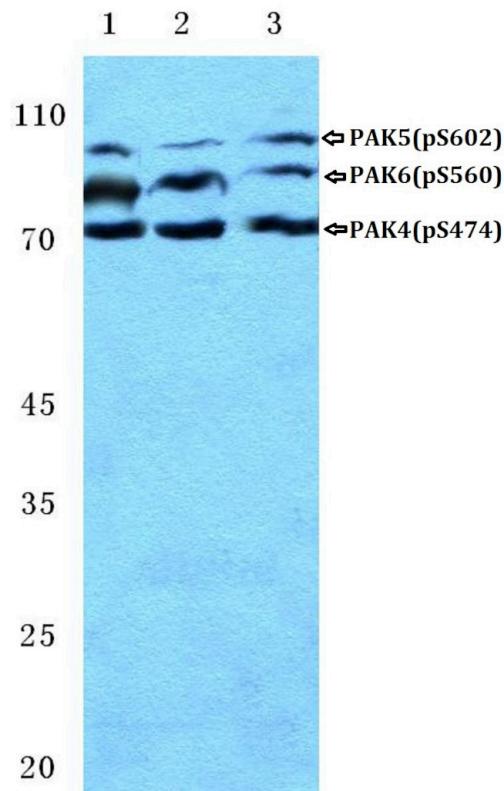

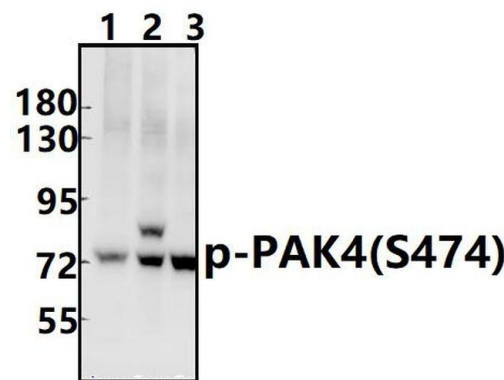
This antibody detects endogenous protein at a molecular weight of 72 kDa (PAK4), 82 kDa (PAK6) and 90 (PAK7).
