In direct ELISAs, approximately 50% cross-reactivity with recombinant human CNTF sR alpha is observed.

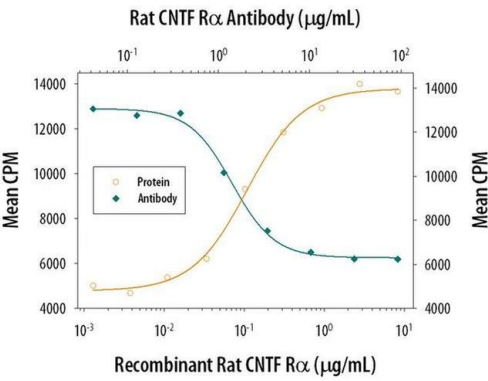
Reconstitute at 0.2 mg/mL in sterile PBS.

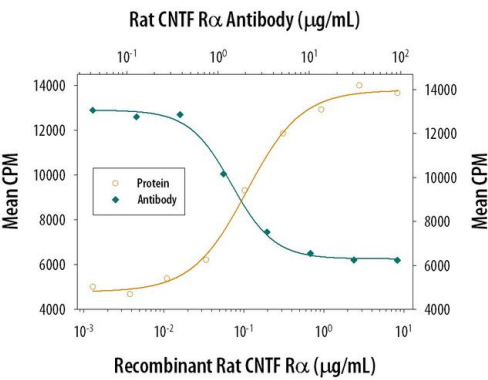
CNTFR Antibody (PA5-47757)

Recombinant Rat CNTF R enhances Recombinant Rat CNTF induced proliferation in the TF,1 human erythroleukemic cell line in a dose-dependent manner (orange line). Enhancement of Recombinant Rat CNTF (10 ng/mL) activity elicited by Recombinant Rat CNTF R (0.25 μg/mL) is neutralized (green line) by increasing concentrations of Goat Anti-Rat CNTF R Antigen Affinity-purified Polyclonal Antibody. The ND50 is typically 2,6 μg/mL.
