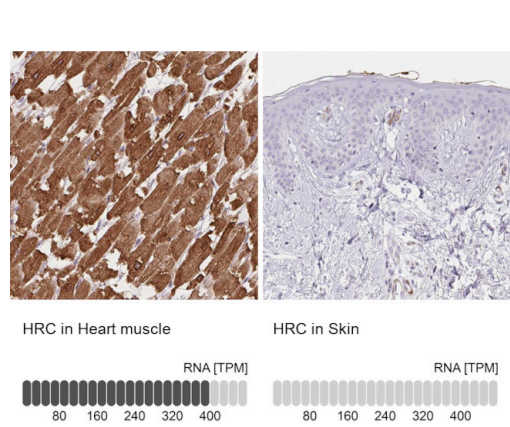

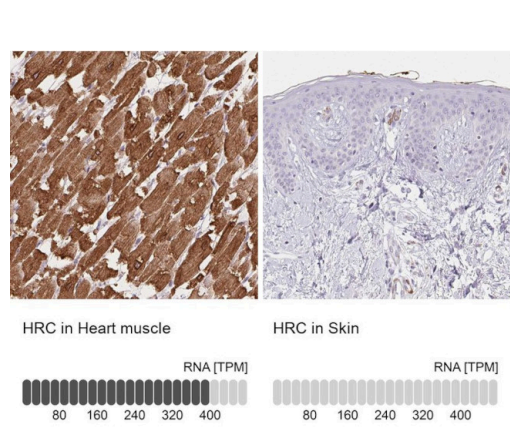

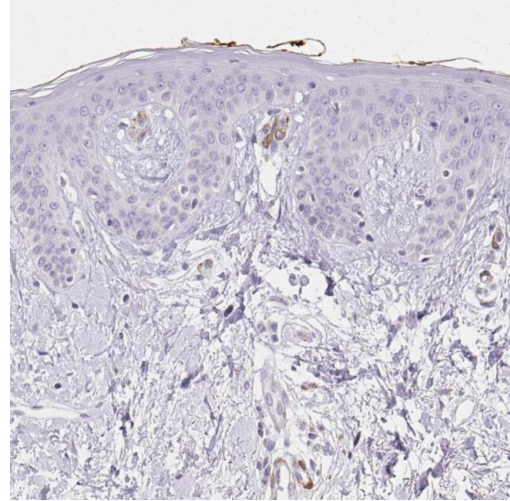
HRC Antibody (PA5-52120)

Relative expression in different tissues in IHC: Detection of differential expression levels of HRC demonstrates antibody specificity. Immunohistochemical analysis of HRC using anti-HRC Polyclonal Antibody (Product # PA5-52120), shows significant staining of HRC in human heart muscle and shows minimal or weak staining in human skin tissues. The relative expression levels of HRC within each tissue is shown using RNA-Seq. {RE}
