




SMARCB1 Antibody (PA5-53932)

Antibody specificity was demonstrated by siRNA mediated knockdown of target protein. HEK293 were transfected with, control siRNA, SMARCB1 siRNA (probe #1), and SMARCB1 siRNA (probe #2) and a decrease in signal intensity was observed in Western Blot application using anti-SMARCB1 Polyclonal Antibody (Product # PA5-53932) used at a dilution of 0.4 µg/mL. Anti-GAPDH was used as a loading control. {KD}



SMARCB1 Antibody (PA5-53932) in WB

Western blot was performed using Anti-SMARCB1 Polyclonal Antibody (Product # PA5-53932) and a ~44 kDa band was observed across the panel tested. Modified whole cell extracts (1% SDS) (30 µg lysate) of A549 (Lane 1), PC-3 (Lane 2), HeLa (Lane 3), K-562 (Lane 4), HEK-293 (Lane 5), MCF-7 (Lane 6), U-2 OS (Lane 7), tissue extracts (30 µg lysate) of Mouse Spleen (Lane 8) and Rat Spleen (Lane 9) were electrophoresed using NuPAGE™ 4-12% Bis-Tris Protein Gel (Product # NP0321BOX). Resolved proteins were then transferred onto a nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (0.4 μg/mL) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain), Superclonal™ Recombinant Secondary Antibody, HRP (Product # A27036, 1: 4000 dilution) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using Novex® ECL Chemiluminescent Substrate Reagent Kit (Product # WP20005).
