



## UQCRC2 Antibody (PA5-53939)

Antibody specificity was demonstrated by siRNA mediated knockdown of target protein. Hep G2 cells were transfected with UQCRC2 siRNA and reduction of signal was observed in Western Blot using UQCRC2 polyclonal Antibody (Product # PA5-53939). {KD}




#### UQCRC2 Antibody (PA5-53939) in WB

Western blot was performed using UQCRC2 Polyclonal Antibody (Product # PA5-53939) and a 48 kDa band corresponding to UQCRC2 was observed in Hep G2, HEK-293, A-431, U-2 OS and Mouse Heart and Mouse Kidney. Membrane enriched extracts (30 µg lysate) of Hep G2 (Lane 1), HEK-293 (Lane 2), A-431 (Lane 3) and U-2 OS (Lane 4), Mouse Heart (Lane 5) and Mouse Kidney (Lane 6) were electrophoresed using NuPAGE® 4-12 % Bis-Tris gel (Product # NP0321BOX). Resolved proteins were then transferred onto a nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (0.4 µg/mL) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain), Superclonal<sup>™</sup> Recombinant Secondary Antibody, HRP (Product # A27036, 1: 4,000 dilution) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using Novex® ECL Chemiluminescent Substrate Reagent Kit (Product # WP20005).

Immunohistochemical staining of UQCRC2 in human cerebral cortex, heart muscle, liver and pancreas using UQCRC2 Polyclonal Antibody (Product # PA5-53939) (A) shows similar protein distribution across tissues to an independent UQCRC2 Polyclonal Antibody (B).
