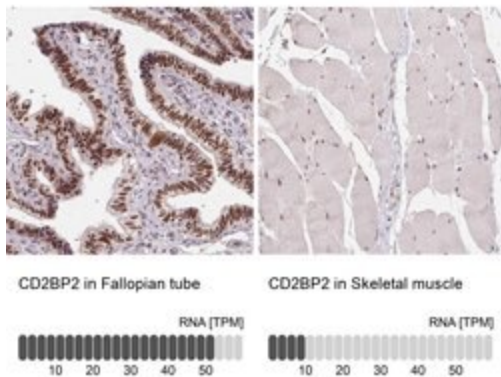

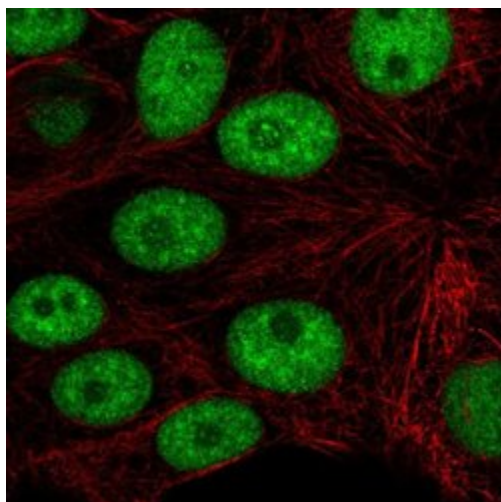

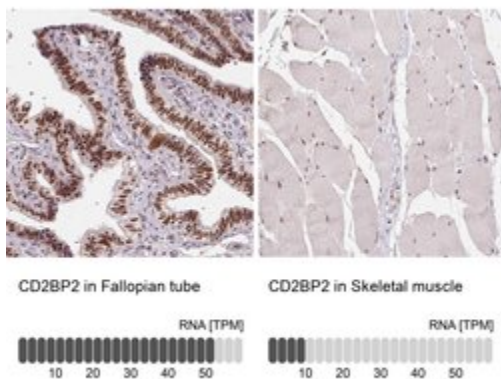


CD2BP2 Antibody (PA5-63947) in IF
