






Calmodulin 1 Antibody (PA5-72529) in ICC/IF

Immunofluorescent analysis of CALM1 in HeLa cells using confocal microscopy. Samples were treated with CALM1 H1 polyclonal antibody (Product # PA5-72529). Alexa Fluor 488-conjugated goat anti-rabbit IgG (green) was used as a secondary antibody and DAPI was used to stain the cell nuclei (blue).

Immunohistochemical analysis of CALM1 in paraffin-embedded human brain tissue. Samples were incubated with CALM1 polyclonal antibody (Product # PA5-72529) followed by a peroxidase-conjugate secondary antibody and DAB staining.

Western blot analysis of CALM1 in HeLa cell lysate using 35 µg of protein per lane. Samples were incubated with CALM1 polyclonal antibody (Product # PA5-72529).
