




#### VAChT Antibody (PA5-77386) in IHC (F)

Samples were probed with VAChT polyclonal antibody (Product # PA5-77386) using a dilution of 1:400, and incubated with DAPI. A) Stained medial septum (green). B) Stained neuronal soma (arrows). Images also show stained nuclei.
