




BCL-XL Antibody (PA5-78862) in WB

Western blot analysis of BCL-XL in Lane 1: rat thymus tissue lysate, Lane 2: NIH3T3 whole cell lysate, Lane 3: HEPA1-6 whole cell lysate, Lane 4: SGC7901 whole cell lysate, Lane 5: HEPG2 whole cell lysate using 50 µg (reducing conditions) per well. Electrophoresis was performed on 5-20% SDS-PAGE gel at 70V (Stacking gel) / 90V (Resolving gel) for 2-3 hours and protein was transferred to a nitrocellulose membrane at 150mA for 50-90 minutes. Sample was blocked with 5% Non-fat Milk/TBS for 1.5 hours at room temperature, incubated with BCL-XL polyclonal antibody (Product # PA5-78862) at a dilution of 0.5 µg/mL (overnight at 4°C), followed by goat anti-rabbit IgG-HRP secondary antibody at a dilution of 1:10,000. Signal development was performed using a chemiluminescence (ECL) kit.

Antibody specificity was demonstrated by siRNA mediated knockdown of target protein. A549 cells were transfected with BCL-XL siRNA and decrease in signal intensity was observed in Western Blot application using Anti-BCL-XL Polyclonal Antibody (Product # PA5-78862). {KD}

Western blot was performed using Anti-BCL-XL Polyclonal Antibody (Product # PA5-78862) and a 28kDa band corresponding to BCL-XL was observed across cell lines tested. Whole cell extracts (30 µg lysate) of NIH:OVCAR-3 (Lane 1), Hep G2 (Lane 2), PC-12 (Lane 3), A549 (Lane 4) were electrophoresed using NuPAGE[™] 4-12% Bis-Tris Protein Gel (Product # NP0322BOX). Resolved proteins were then transferred onto a Nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1:1000 Dilution) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain) Superclonal[™] Recombinant Secondary Antibody, HRP (Product # A27036, 1:4000 dilution) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using Novex® ECL Reagent Kit (Product # WP20005).
