
Reconstitute with 0.2 mL of distilled water to yield a concentration of 500 µg/mL.


DGCR8 Antibody (PA5-79151) in WB

Western blot analysis of DGCR8 in Lane 1: human HeLa whole cell lysate, Lane 2: human placenta tissue lysate, Lane 3: human COLO-320 whole cell lysate, Lane 4: human HepG2 whole cell lysate, Lane 5: human A549 whole cell lysate, Lane 6: human MCF-7 whole cell lysate, Lane 7: human 22RV1 whole cell lysate using 50 μ g (reducing conditions) per well. Electrophoresis was performed on 5-20% SDS-PAGE gel at 70V (Stacking gel) / 90V (Resolving gel) for 2-3 hours and protein was transferred to a nitrocellulose membrane at 150mA for 50-90 minutes. Sample was blocked with 5% Non-fat Milk/TBS for 1.5 hours at room temperature, incubated with DGCR8 polyclonal antibody (Product # PA5-79151) at a dilution of 0.5 μ g/mL (overnight at 4°C), followed by goat anti-rabbit IgG-HRP secondary antibody at a dilution of 1:10,000. Signal development was performed using a chemiluminescence (ECL) kit.



DGCR8 Antibody (PA5-79151) in ICC/IF

Immunocytochemistry analysis of DGCR8 using anti-DGCR8 antibody (Product # PA5-79151) . DGCR8 was detected in a section of A431 cells. Enzyme antigen retrieval was performed using IHC enzyme antigen retrieval reagent for 15 mins. The cells were blocked with 10% goat serum and then incubated with 2g/mL rabbit anti-DGCR8 antibody (Product # PA5-79151) overnight at 4°C. DyLight®488 Conjugated Goat Anti-Rabbit IgG was used as secondary antibody at 1:100 dilution and incubated for 30 minutes at 37°C. The section was counterstained with DAPI. Visualize using a fluorescence microscope and filter sets appropriate for the label used.



DGCR8 Antibody (PA5-79151) in IHC (P)

Immunohistochemical analysis of DGCR8 in paraffin-embedded section of mouse small intestine tissues. Heat mediated antigen retrieval was performed in citrate buffer (pH6, epitope retrieval solution) for 20 mins. The tissue section was blocked with 10% goat serum. The tissue section was then incubated with 1g/mL rabbit anti-DGCR8 antibody (Product # PA5-79151) overnight at 4°C. Biotinylated goat anti-rabbit IgG was used as secondary antibody and incubated for 30 minutes at 37°C. The tissue section was developed using Strepavidin-Biotin-Complex (SABC) with DAB as the chromogen.
