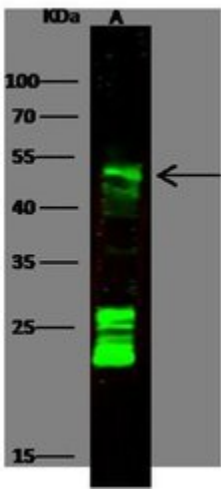
This product is preservative free. It is recommended to add sodium azide to avoid contamination (final concentration 0.05%-0.1%).

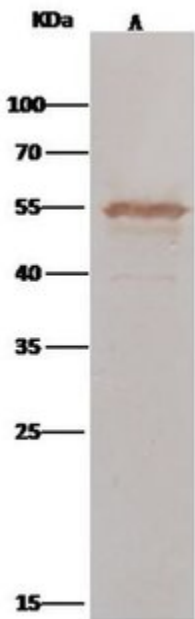
CNDP2 Antibody (PA5-81361) in WB

Western blot analysis of CNDP2 in Lane A: 293T Whole Cell Lysate (30 µg). Samples were probed using a CNDP2 Polyclonal Antibody (Product # PA5-81361) at a 1:500 dilution, followed by a Goat Anti-Rabbit IgG (H+L), Dylight 800 Secondary Antibody at a 1:10000 dilution. Western blot was performed under reducing conditions. Predicted band size: 53 kDa. Observed band size: 53 kDa.
